



Lot One (1) of the Schaumburg Post Office Subdivision, which is part of the Northeast Quarter (1) of Section 21, Township 41 North, Range 10 East of the Third Principal Meridian in Cook County, Illinois.

SECTION THREE: The Village Clerk is hereby directed to record said plat within six (6) months of the date of approval.

SECTION FOUR: This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
